## REFER A FRIEND ARIA HUNTER VALLEY \$10K VISA GIFT CARD PROMOTION Terms and Conditions

Huntlee Pty Ltd ("Promoter") 1 Triton Boulevard, North Rothbury, NSW 2335, is the promoter of this "Refer a Friend - Aria Hunter Valley \$10K Visa Gift Card Promotion".

By participating in this promotion, participants agree to be bound by the following terms and conditions:

- This promotion applies to the referral of a new purchaser ("Friend") who settles on their purchase of a Valid Lot at the Promoter's Aria Hunter Valley development in Rothbury, NSW 2320 and successfully settles on that lot. For the purposes of this promotion, a Friend may include a friend, associate, or family member, but not a corporate entity unless approved by the Promoter in its absolute discretion.
- A Valid Lot shall be one of the following residential lots available for sale in Deposited Plan DP1281438: 111, 112, 118, Deposited Plan DP1212935, 127, 128 and 132 and Deposited Plan DP1281439 211, 212 and 215 of the Aria Hunter Valley land release at the time of referral. The Promoter may update the availability of Valid Lots at its discretion.
- 3. To be eligible to refer a friend, the referring participant ("Referrer") must be a purchaser of at least one lot in Aria Hunter Valley who has settled on their own lot prior to the date of referral.
- 4. Both Referrer and Friend must complete and sign the official referral form provided by the Promoter, prior to the Referrer receiving their prize, to be eligible for the promotional reward.
